

# President's Message...

In my first message of the year I covered the Taylor Law and its history. As I sit here on this late November day, I thought I'd add a sequel which covers union representation... Did you ever wonder why you are entitled to union representation? Weingarten Rights and Cadet Rights are important things to know if you are ever called into a meeting.

On July 18, 2007, Gov. Spitzer signed a bill which restored Weingarten Rights for public employees in the state of NY. In a decision by the NYS Court of Appeals in February 2007, public employees lost the right to representation in interviews or investigations that could lead to discipline. The bill amends the Taylor Law by explicitly making it an improper practice for a public employer to deny an employee's request for union representation when the employee is facing an interview by the employer that could reasonably lead to potential discipline. Weingarten rights guarantee an employee the right to union representation during an investigatory interview. Only employees who are in a union have Weingarten rights.

When should you ask for union representation?

If a principal or other supervisor calls you into a meeting to obtain information which could be used as a basis for discipline or asks you to defend your conduct or if you have a reasonable belief that discipline may result from what you say, you have the right to request union representation and should ask for such representation.

Examples of such meetings are:

- 1. The purpose of the meeting is to investigate an employee's performance where discipline, demotion or other adverse consequences to the employee's job status or working conditions are a possible result.
- 2. The purpose of the meeting is to elicit facts from the employee to support disciplinary action that is probable or that is being considered, or to obtain admissions of misconduct or other evidence to support a disciplinary decision already made.
- 3. The employee is required to explain his/her conduct, or defend it during the interview, or is compelled to answer questions or give evidence.

You may ask for union representation before or even during a meeting. It is your right.

Do you need to answer every question during a meeting? The answer is 'no' due to something known as Cadet Rights. The 3020-a hearing process is the sole method by which tenured teachers can be disciplined in NYS, and the statute provides that no teacher can be compelled to testify at the hearing. Consequently, it has been established that a teacher can refuse to answer questions, without being found insubordinate, during an investigation that the teacher believes could lead to disciplinary action. The Cadet Rights were established through a disciplinary case involving a tenured teacher who was found guilty of misconduct through a 3020-a hearing. However, the decision of the hearing officer to dismiss a charge of insubordination was appealed by the school district. The insubordination charge was related to the teacher's refusal to answer questions during an investigation prior to the hearing. In the appeal decision, the Commissioner of Education agreed that a teacher need not answer questions in any pre-hearing investigation which could lead to a 3020-a hearing. The decision was affirmed by the courts.

### **Annual NYSTRS Conference**

On November 5-7, 2016, Mark Hanik, Kat Kelly, and Debra Puccio represented Syosset teachers at the 2016 annual meeting of NYSTRS delegates. More than 700 delegates attended the conference at the Saratoga Springs City Center. For two days, NYSTRS delegates attended a variety of seminars that covered topics ranging from NYSTRS benefits, pension options, and Social Security to NYSTRS communication updates, economic/market trends, and keeping your personal information secure. On the third day, NYSTRS delegates attended the business portion of the conference. Delegates took part in a question-and-answer period with the NYSTRS Board and staff. The business was concluded after annual elections were held. Jolene T. DiBrango, teacher from the Pittsford Central School District, was re-elected to a three-year term on the 10-member Retirement Board.

Recently, you should have received your NYSTRS Benefits Profile in the mail. The Profile booklet contains the same important and personal information as it has in the past. But, this year, the booklet was folded in half and mailed in a smaller envelope. Please make sure you received your copy. Please be sure to look over your designated beneficiaries. Sometimes our situations change due to divorce, marriage, or death; you want to make sure the person(s) you previously designated is/are still the person(s) you want now. You can download a "Change of Beneficiary" form on nystrs.org or you call NYSTRS for beneficiary information at (800) 348-7298 x.6130. Any changes you make at NYSTRS should also be made at Syosset for any district policies you carry. Contact Karen Femminella at the Syosset Benefits Office at ext 5664.

If you have already set up a MyNYSTRS online account at nystrs.org, your Profile booklet can also be downloaded. If you haven't set up a MyNYSTRS account, we strongly suggest you do. You will need your Employee ID number which can be found on your Profile booklet. Setting up a MyNYSTRS account is especially useful for those retiring. Status of paperwork can be tracked and information specific to your personal options are confidentially stored in your account.

Those retiring this year, or in the next few years, want to stay informed with pension options and deadline dates for filing. Attending a PREP seminar, hosted by NYSTRS, is very helpful. You need to register for the seminar. Please be advised that they fill up fast. Search dates online at the NYSTRS website or call NYSTRS directly at (800) 348-7298 x.6180. In addition, you can arrange for a retirement consultation via video conference to get the process started. NYSTRS staff members are extremely knowledgeable and can best direct you according to your personal needs. It is important to note that everyone's financial and personal life is unique. Please speak with a NYSTRS representative before making these important and binding decisions. They are the professionals and the only ones qualified to address your needs.

## Letter of Intent (LOI)

For the Syosset district, you will need to file a letter of intent to receive retirement benefits. Teachers interested in retiring in the 2016-17 school year, must inform the district of their intent to retire **five** months prior to the date of retirement.

- The LOI is not binding, provided teachers word their letters correctly. Sample provided below.
- Remember, even if you plan to leave before or after June, you must give five months prior notice of intent and three months prior notice of resignation. (For example submit LOI by February 1st for a June retirement.)
- A "Letter of Resignation" must be submitted at least three months prior to leaving. (For example, submit "Letter of Resignation" by April 1st for June retirement.)
- Letters should be sent to the Superintendent of Schools, Dr. Thomas Rogers.
- If you submit your LOI and do not follow up two months later with your Letter of Resignation, your original LOI becomes null and void.

### Sample Letter of Intent for Retirement

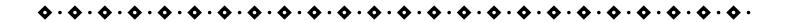
It is my intention to retire at the end of this school year (or date of intent).

I reserve the right to remain employed as a teacher by the school district should my plans change.

Please accept this letter in fulfillment of my obligation to give five months prior notice of my intention to retire as required by the teachers' contract.

### Sample Letter of Resignation for the Purpose of Retirement

As of (date), for the purpose of retirement, I resign my position as a teacher in the Syosset Central School District.
